

**Veterans who served in Thailand during the Vietnam Era**

This document shows approved VA claims for veterans who served in Thailand during the Vietnam era. Either the VA citation number is shown, or the have the docket number is shown, other cases are shown as DROD (Decision Regional Office Decision - a previously denied claim by the Regional Office which decision was later changed and approved the claim by decision of the Regional Office). The decision date is that date the VA approved the veteran's claim shown in YYYY-MM-DD format. Each citation also has an archive date which I don't show, however the citation archive date is about 2 weeks after the approval date. If the veterans was represented by a group that is listed as: American Legion, Disabled American Veterans (DAV), Veterans of Foreign Wars (VFW), a state veteran group or the name of the VA attorney who represented the veteran. Dates veteran in Thailand as shown on the citation docket. DROD cases generally don't show the dates the veteran served in Thailand. Notes I try and show which base, or bases in Thailand the veteran served and the veteran's job specialty while in Thailand, when known. Name of the veteran is not shown.
