## GENERAL INSTRUCTIONS

- Upon rept to the out-processing cen, insure that you have:
  - The equiv of a min of \$125US for conversion to US curr. Fac for cashing checks and money orders are not avail or very ltd at most sites. With the exception of Hawaii, there are no fac for cashing US Savings Bonds at R & R sites.
  - Current Armed Forces ID Card and Imm Rec (and pspt if req). Lack of proper imm causes more delays than any other item.
- Max bag gty is 40 lb (Exception: Hawaii--66 lb). Insert a copy of your orders in all bag. You and your bag might become sepr.
- You will perf tvl in mil unif and wear civ cld while actually on R & R. (Exception: Hawaii--unif may be worn on site.)
- All pers must rept on time for rtn flt. Pers missing rtn flt WB rept to their units and may be req to rtn to Vietnam at their own expense.
- Customs reg prohibit the fol on acft: Narcotics, marihuana, explosives, ammo, fireworks, knives, Vietnamese curr in ex of 500 piasters, gold or silver bullion, articles produced in Communist China, North Vietnam or North Korea, obscene or pornographic articles or literature, items in ex of demonstrable needs, more than one bottle of alcoholic beverage and more than one carton of cigarettes.
- The carrying of any kind of dangerous article (hand grenades, tear gas grenades, signal kits, etc.) firearms ammo, explosive or incendiary ammo, or any kind of explosive device in accompanied or unaccompanied personal baggage aboard mil acft is prohibited.
- Airline reg forbid intoxicated pers from being booked on acft.
- Pers traveling to Hawaii on R & R are not permitted to lv Hawaii for CONUS.
- Exp involved in the exec of these permissive TO are borne by the indiv traveling and not reimb by US govt.
- Pas and/or R & R in the Saigon/Cholon area is not auth.
- Tvl under the auth of this order is not auth in connec with PCS, TDY or leave except as prov by MACV Directive 28-2.
- Appl to Australia: Indiv must have on their person prior to bd and while traveling to Australia a cert from a med off accomp w/ 24-hr of dpnt fr Vietnam stating that the traveler is free of any demonstrable infectious disease.
- Supplemental Instructions or Information (For Local Command Use): Change \$125 US to read \$200 US R&R personnel are to check in at the Bkk R&R Center in the Suriyothai Bldg, corner of Phaholyotin Road & Soi 2. Personnel are authorized return transportation aboard the R&R aircraft from TSN to Bkk. TRAVEL AUTHORIZED BY THIS ORDER DOES NOT ENTITLE TRAVELER TO EXPENSES OF TRAVEL.
